IMPORTED BEEF METHODOLOGY NOTICE

Urner Barry is continuously soliciting feedback from stakeholders to ensure that our coverage reflects current trading conditions and practices. To improve market transparency and to provide stakeholders meaningful information, Urner Barry is proposing the following changes to its imported beef reporting methodologies:

- Aligning our spot market coverage to include transactional and market data for product to deliver up to 14 days from the date of publication.
- Realigning our coverage in our 7–45-day listing to include transactional and market data for product to deliver 15-60 days from the date of publication.
- Realigning our 46–90-day listing to include transactional and market data for product to deliver 61-120 days from the date of publication.

The establishment of these delivery periods will appropriately list comparable transactions together, accurately reflect current trading practices, and capture more transactions in forward periods. The resulting coverage would appear as follows in our price table:
